Developed methodological approach, conducted interviews with key stakeholders, and guided the production of the findings document.

The training established an understanding of gender in humanitarian settings, improved gender integration throughout surge deployments, addressed context-specific challenges like the Ukraine response, promoted awareness of localization through partnerships with women's organizations, deepened participants' knowledge of gender-based violence, and equipped them with practical skills to apply in their roles.
- **UNICEF:** Led two separate investigations (including fieldwork) on the benefits of gender components within UNICEF's Vitamin A supplementation programs in Benin and Guinea.
- **UNDP Armenia:** Led the development of online training modules on gender-sensitive monitoring and gender-sensitive communication for Armenian civil servants.
